Call to Order and Review of Agenda (Erin Gangloff, Co-Moderator):

• Called meeting to order at 6:33 p.m. (MT)

Reviewed agenda.

Prayer Time (Pastor Alice Horner Nelson):

- Made additions to the most recent prayer list.
- Centered Council's thoughts through intentional breathing, shared a blessing "For This Tired Day," and prayed.

Approval of August Council Minutes (Erin Gangloff, Co-Moderator):

- Asked if there were any changes or additions to the Minutes that had been sent out. There were none.
- August Minutes were approved as read.

Financial Report for August 2023 (Cindy Ponikvar, Church Treasurer):

- August Financial Review:
 - o Total Operating Revenues were \$36,957.54
 - o Total Operating Expenses were \$70,172.74
 - o Net Operating Loss as of August 31, 2023 was \$33,215.20
- Provided a Year over Year (2022/2023) report as of August 31
- A question was asked about what is in the "Earned Income" line item.
 - o Cindy explained that Earned Income has sub accounts including Building Use Fees; Fee Income, and Other Income. In particular, Building Use Fees (the largest of the Earned Income items) are funds that have been allocated to the Operating Budget. The total annual allocation is \$21,600 spread over 4 quarters at \$5,400 each quarter.
- Barbara Ford's \$30,000 bequest is still in the operating budget in an unrestricted fund until designated for use. The money will be moved from the operating budget at the end of the year.

Lay Leadership Structure at Calvary (we will discuss at tonight's meeting)

Random item(s):

- Kentucky Circle Village "Re-stock the pantry" challenge launched on Gathering Sunday and culminates on October 1, World Communion Sunday
- World Mission Offering emphasis runs throughout the month of October
- Will be attending (virtually) the Evergreen ABC-USA Region Annual Meeting October 12-14
- Am in the process of annual performance reviews for staff (October and November)

Ministry Teams:

• Missions Ministry Team:

- o Mission Payments from our operating budget have been going out as scheduled.
- Missionaries Nora & Pieter Kalkman (Europe & Middle East) reached out to Calvary to come on October 1st and share about their ministry. Executive Minister of American Baptist Churches of the Rocky Mountains (ABCRM), Steve Van Ostran, introduced them to me at the ABC-USA biennial in Puerto Rico in June. The Kalkmans will be in Denver for the ABCRM annual gathering and wanted to present at Calvary on October 1. In conferring with the Missions Ministry Team, we declined their offer (with compassion and encouragement) on the basis of our goal of supporting fewer global servants at a higher rate (rather than more global servants at a lower financial support rate).

• Insight Leadership Team:

- o Rick Breitenbecher will give full update, but a few notes:
 - Moving to monthly meetings in October to allow more time for sub-teams to meet
 - I handed off the pastoral support for the "Evaluation of Ministry Programs" subteam to Pastor Morgan now that she is back from sabbatical.
 - I continue to work with the Financial Wellness sub-team
 - A couple of us met with some representatives from Thrivent to hear about educational workshop opportunities; we have not yet made a decision about this; will speak with staff about two possible opportunities.
 - We have a meeting scheduled in October with Pastor Alice to discuss the feedback received at the August 27 forum on how people would like to receive financial information about Calvary (what types of information, what format it's communicated, etc.)
 - Evaluation of Connect 2 is beginning. Connect 6 groups have launched.
 - New FAQ document with all of our linked documents is available on the website, and ILT representatives are in narthex twice a month to answer questions from congregation members.

Faith Formation (Pastor Morgan Fletcher):

- Read a section from chapter four of *How To Lead When You Don't Know Where You're Going?*, which had been previously distributed to Council this summer
- Asked whether each Council member naturally gravitated toward A Decision Making or A
 Discerning Approach. Overall discussion showed there were benefits to both. We all need

to consider what the other person might be saying. Both decision and discerning can be closely aligned.

Council Discussion – Lay Leadership Structure (Senior Pastor Anne Scalfaro & Co-Moderator Erin Gangloff):

Pastor Anne stated that lay leadership is the foundation of the church. She invited us to consider a potential shift in how lay leadership at Calvary is structured, naming several reasons, including:

- During COVID things were naturally heavily staff led, and now we are moving more and more back to lay leadership we are still making our way with this and things are 'clunky' in terms of efficiency and participation. Burnout is still evident.
- Bill Warren presented a plan to Executive Committee for possible changes to Resource Management structure, involving changing the committee as we think of it today. There are many reasons for this, including needing terms without limits or much longer limits for expertise in certain areas. How budgeting works (on a practical level) is also a factor, and having a full time Facilities & Operations Manager.
- What Bill is seeing in Resource Management, is something we see in most of our
 committees right now. High expertise in the chair position that takes a long time to
 master/learn because of the complexity of those positions. Continual turnover is not
 necessarily a benefit in these areas. Additionally, many other members on these
 committees may not be needed, and therefore could be freed up to volunteer and serve in
 other ways.
- We have been discussing the role of at-large members on Council, and the role of Council as a whole.
- Ministry Teams are functioning well, but usually only when staff initiated. Committees have to wait to be elected and serve limited terms.
- The ILT has been drafting some policies around how it functions to bring before Council.
- We are already beginning an evaluation process for lay leadership in mission program areas this fall, and will continue with faith formation areas this spring. If those ministry team and program leadership models are being examined, it makes sense to examine our overarching lay leadership structure as well.
- There are different models of church leadership: For example, many churches have a smaller board that is more like a Board of Trustees that deals with the financial/executive matters of the organization (requiring laity with expertise in certain areas), and then have a visioning/ministerial board that is more agile and requires a different skill set (sometimes called Deacons or Council). These groups meet separately as they have a separate purpose, but then come together once a quarter or however frequently as needed as one larger leadership body especially for big votes such as on the budget.

All of these factors (and more), are leading the Executive Committee to look at our entire lay leadership structure at Calvary and how that functions with pastors – to ensure we are meeting Calvary's needs at this time. We could wait, but why wait when we have this opportunity. It falls naturally within our discernment data and findings. In addition, we cannot really address (in full) items such as staffing needs and financial wellness, until we have a lay leadership structure that is working at its full potential – maximizing the gifts within our congregation. This is a very big discussion, and potentially includes:

Looking at all areas of lay leadership and volunteers.

- Changing bylaws and policies and procedures.
- Going to the congregation for a vote to delay our regular voting process on the traditional nominating ballot, meaning, we would most likely not be ready to vote on lay leadership in January.
- Asking current Council and committee members to extend their terms a few months past January while we figure out the best way forward.
- Continual listening to the Spirit if we need to take longer to make big decisions for our church.

Erin Gangloff posed 3 questions, followed by a discussion by Council members:

- What is best for Calvary?
- What should the structure look like?
- Do we need to pause to figure this out?

Many comments were made during discussion, indicating that there is a need for such a review of our lay leadership structure.

Erin Gangloff stated the goal was to have an outside facilitator help Council and the ILT to review our structure based on changes. This would take a few meetings (most likely on the weekends) with those who are interested from Council and ILT and others to really work and dream about new possibilities.

Pastor Anne asked the questions:

- Do you also feel, overall, that we need to re-examine our lay leadership structure?
- Do we have the sense, as well, that our structure isn't serving our current needs in the best way?

The outcome to the discussion was an official vote, with all Council members voting YES, to move forward with the plan to re-examine our lay leadership structure. All Council members agreed to extend their service time several months until our lay leadership structure is finalized to meet our church needs.

Wrap-up (All):

• An update was requested about the lady involved in the church break-in. Pastor Anne responded there has been no response to her several attempts to contact the woman, who has not been back to Bootstraps. Pastor Anne & Chad Lawrence (Facilities and Operations

Manager) are not considering pressing charges at this time; we are still hopeful about a process of grace and reconciliation should the woman return to Calvary's premises.
